

Contest « Fashion Nude »

Edition 2018 – Competition Rules

Article 1 – Presentation of the [competition/contest](#)

Normal and the world of photography launch a new competition [on the occasion of/to mark the release](#) of its 12th issue and the Month of Photography in Paris. The aim is to promote artistic diversity on the Fashion Nude theme and to find young or emerging talents. The main purpose of this new [competition/contest](#) is to complete the dynamic already established through a process of promotion and discovery. This allows us to renew our references and we can, therefore, consider future publications.

Article 2 – Theme and categories

The theme of this first edition is “Fashion Nude”. A panel of awards will reward some laureates. These are :

- The “Grand Prix du Jury “will award three laureates
- Three other participants will be selected by the public and will thus obtain the Public Prize.
- The Selection of Partners will support six winners for their work.
- The “Coup de Cœur Normal “ will be delivered by Normal to a laureate.

Article 3 – Conditions of participation.

Participation is free, open to everyone over 18 years old; whether you are [amateurs/enthusiasts](#) or professionals.

If you want to take part in the contest, you must send digital files. This must be [sent with/accompanied by](#) references of the author and his photograph, in accordance with the conditions in articles 4 and 5. By participating in a mailing, the author declares to have read and accepted the conditions of participation published in the contest rules. He also claims to be the author of the photograph.

Article 4 – Mandatory particulars

To be [validated/approved](#) each photographic file must be accompanied by the following mentions: name and first name of the author, postal address of the author, telephone number and mail of the author.

The mention “I authorize Normal Magazine to reproduce this photograph in order to promote the “Fashion Nude” Contest” must appear in the mail.

The mention “I have read the contest rules and I accept the conditions if participation” must also be [attached/linked](#) to the mail.

Article 5 – Technical conditions

Digital files are sent by email to this contact address : contest@incarnatio.fr .

The size of transmitted images is fixed at 1MO. Other technical conditions will be applied after the selection – for this refer to Article 10.

The jury reserves the right to contact the author in case of conflict about the technical configuration of the file or the origin of the photograph. Any step in this direction has the effect of suspending the participation of the author pending his response.

Article 6 – Deadline for participation

The deadline for mailings is September 30, 2018 at midnight. The date and the time of reception of the mail being authentic. The jury is sovereign for the validation of the shipments.

Article 7 – Fashion Nude Competition Prize

Only on theme is proposed for this contest: “Fashion Nude”. Nevertheless, the participants will be rewarded with various prizes: the “Grand Prix du Jury”, the Public Prize, the Selection of Partners and the “Coup de Coeur Normal”. Awards associated with these awards will consist of various prizes from partners and from Normal Magazine.

Nikon and Profoto offer photography equipment to the first winner of the “Grand Prix du Jury”. Profoto will offer an A1 flash.

The Salon de la Photo offers to the opportunity for some laureates to be exhibited at the 2018 Photo Show, which will be held in Paris from 8 to 12 November.

Focus Numérique, l’Œil de la photographie and Normal Magazine offer a relay of the contest throughout their media channels.

Article 8 – Publication of results

After the deliberation of the jury which will take place in October 2018, the winners will be announced on the website www.normal-magazine.com and on the media channels available to Normal Magazine. The winners will be informed by email as soon as possible. Each award-winning participant will receive an invitation to the awards ceremony during [the opening of the exhibition/the vernissage](#) at the Red Art Factory.

Article 9 – Jury and selection criteria

The jury is composed of photographers, enthusiasts, professors, experts and professionals in the field of art and photography. Jury members can not participate in the photo contest. The jury will deliberate in October 2018.

The selection criteria will be those that are generally applied in photography and will take into account the theme of the contest, “Fashion Nude”.

Selection process: A pre-selection is carried out after a participation validation and according to the different prizes awarded. A second selection determines the finalists and winners of the contest according to each prize.

Regarding the preselection of photographs for the public’s prize, it will be done by ENS Louis Lumière students.

In case of doubt of conflict, a photograph may be suspended from the selection. For example if the author did not provide an answer after the preselection. The jury is sovereign and reserves the right to refuse a photograph in case of dispute on one or more criteria.

Article 10 – Results

The authors of the selected photographs will be contacted by email or phone. A copy in high definition will be asked to the authors [in order to print it /make prints](#). These prints will be the subject of an exhibition at the Red Art Factory, a publication in the

Normal No. 12 and an exhibition at the 12th edition of the Salon de la Photographie to be held in Paris in November 2018.

Date and place of the awards ceremony : The announcement of the results will take place [on the vernissage / on the opening of the exhibition / on the exhibition opening](#) at the Red Art Factory. Laureates will be published in the Normal No. 12 and on the media channels that Normal and its partners own.

Article 11 – Ethics

Authors are committed to have shooting permissions of the people in their picture. The jury reserves the right to reject any photograph that does not have the permission of the persons photographed. In case of photography taken in private space, the author agrees to have [the private owners permissions / the permissions of the owners of the space concerned](#).

In case of doubt these ethical elements, the jury reserves the right not to retain a participation.

Article 12 – Publication of the competition

The announcement of the results implies that the authors authorizes the publication of their works on the communication media of Normal magazine, its partners and in various media in the exclusive context of the “Fashion Nude” contest. The authors undertake to authorize the presentation of their photos as part of the contest and at subsequent exhibitions designed to promote the contest.

The results will be published on the Normal magazine website and through his media channels.

Article 13 – Contest Rules

Article 14 – Remedies

Participation implies that the photographer approves the whole competition rules. [The e-mail reception establishes the acceptance of the competition rules/applies to the competition rules](#). In case of conflict or doubt about the quality and origin of the photograph, the jury reserves the right no to retain a participant. These contest rules are subject to French law.

Article 15 – Challenge/Contestation of results/outcome

The jury is sovereign in term of selection. Participation in the photo contest implies the approval of contest rules and [results/outcome conditions](#). No [claim/demand](#) can be taken into account.

Article 16 – Data Protection Act

The information provided by the participants can be used in the “Fashion Nude” photo contest. In all cases, [it is reminded that](#), in accordance with the Data Protection Act of 6 January 1978, amended by Law No. 2004 -801 of August 6, 2004 relating to the protection of individuals [with regard to/about the processing of personal data](#), and Decree No. 2005 - 1309 of October 20, 2005, the participants benefit from the organizer of the contest of a right of access, interrogation, opposition, rectification and deletion for the data concerning them, on request. Normal magazine ensures the smooth running of the exhibitions and the publication as well as the respect of the mentions of copyright/royalties.

Article 20 - Filing of photographs

Normal Magazine owns exhibitions and publication of the "Fashion Nude" contest. As part of the contest promotion, it may be required [to broadcast/release/share the work](#) of the photographers who participated in the contest with the copyright notice of the photographs.
